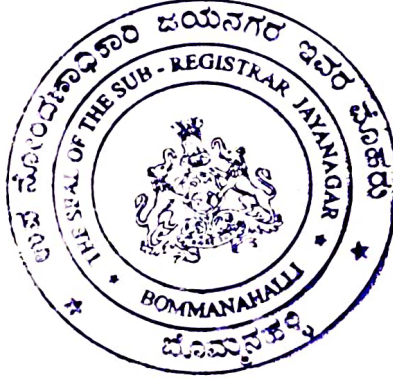

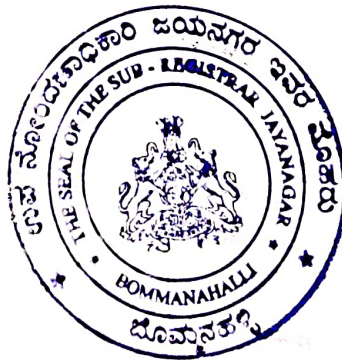

G, To open accounts in the name of Trust with any Nationalized/Scheduled or Co- Operative, Private Financial Institutions or Bank, operate such accounts and to give instructions to the banks and to provide for the opening of such accounts by Executive Committee and Secretary.

H, To appoint constituted attorneys or agents and delegate to such attorneys or agents or delegate to such attorneys or agents all or any of the powers vested in them under these presents and from time to time remove such attorneys or agents and appoint other or others in his/her or their place.

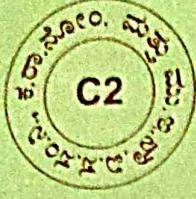

L, To join, co-operate or amalgamate this trust with other or others having kindred or allied objects upon such terms and conditions as the trustees may in their discretion think fit particularly having regard to the objects and nature of this trust.

8. OFFICERS OF THE TRUST

A, President, b, Managing Trustee/Secretary shall be the officers of the Trust.

THE PRESIDENT

A, He/She will be elected from among the Trustee and he/she shall hold office for a term of three years. He/she is eligible for re-election.

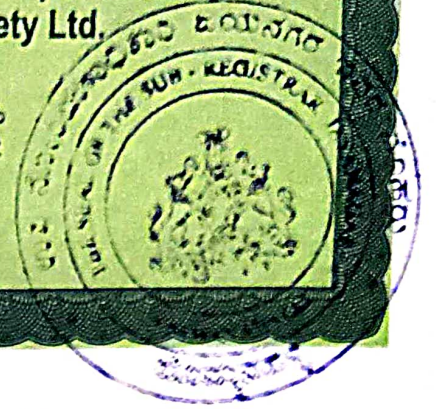

B, He/she shall be the Chief Executive of the Trust and shall be responsible to execute the objects of the Trust and implement the policies of the Trust.

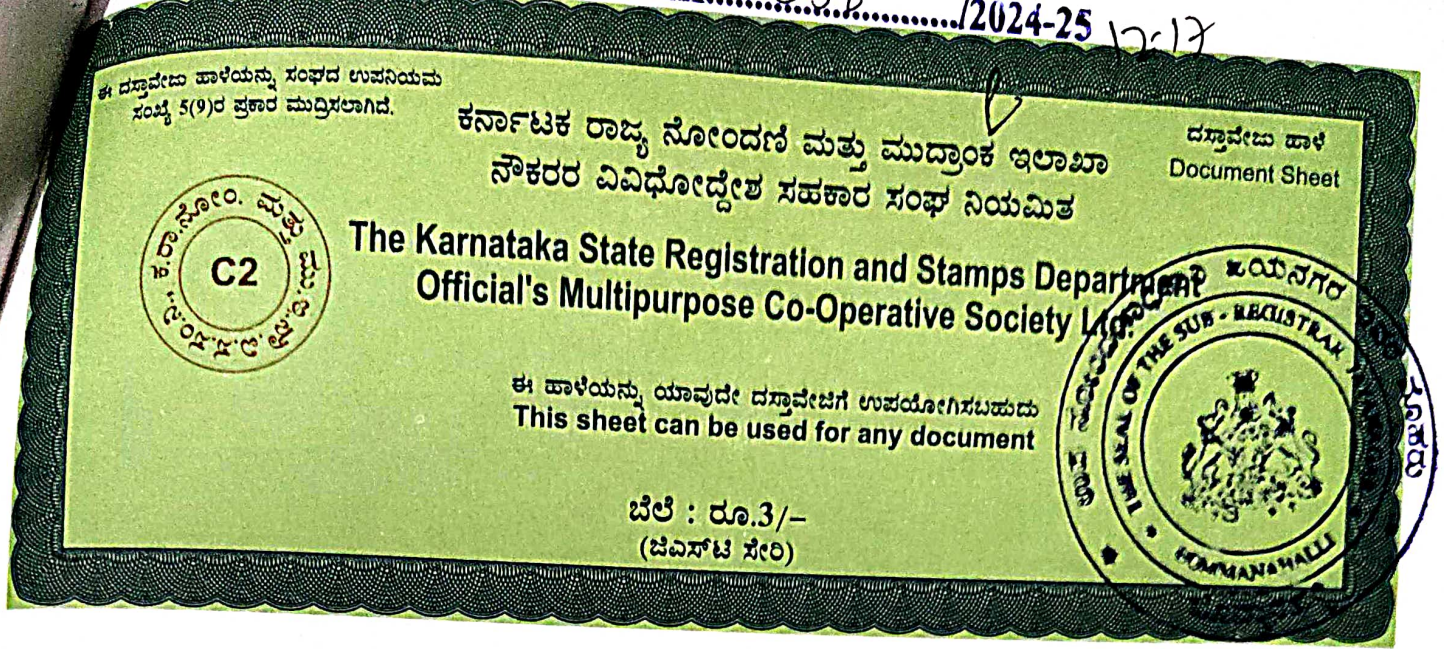
C, He/she shall attend to all the statutory requirements implied on the Trust.

G, He/She shall get the accounts of the Trust audited annually by an approved practicing Chartered Accountant.

H, He/She shall prepare and present the annual account and budget to the Board of Trustees and the Annual General Meetings of the Trust.

I, He/She shall file the returns and reports to the Income tax and any other authorities needed.

J, He/She shall generally be in charge of the office and the custodian of all documents, bank passbook, cheque books, security documents and oversee the day -to-day expenses of the Trust.

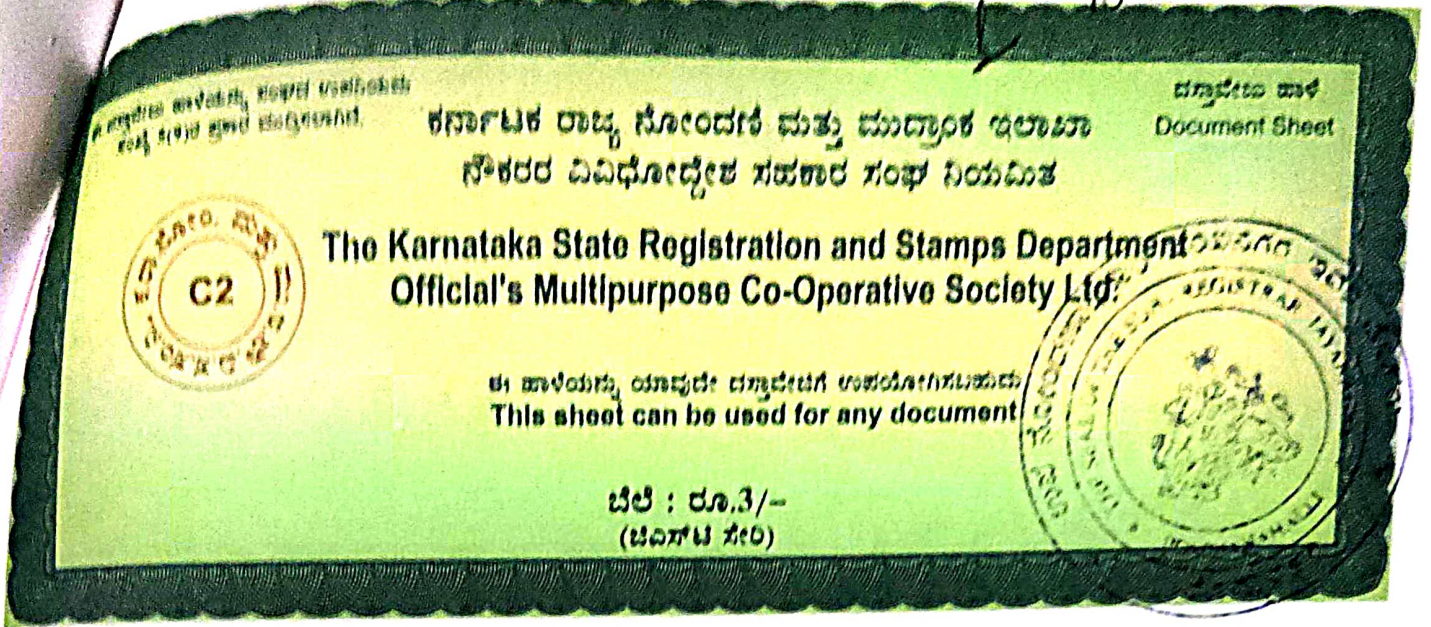
K, He/She shall ensure bills, cash memos, invoices are obtained for all purchases made against cash/cheque payments and maintain a proper accounts of such expenditure.

L, Under the guidance & advice of the board of management and he/she shall be authorized to appoint, dismiss, reinstate any of the employee and can appoint temporary substitute staff and fix their remuneration. He/she shall grant leave of absence, and generally ensure smooth function of the Trust.

M, He/She shall organize and supervise the correspondence record work, accounts and the clerical work.

N, He/she shall make all necessary temporary appointments of staff or employ workers and pay wages for the carrying out of the objects of the Trust with the consultation of the board of management.

THE PRESIDENT/TREASURER

They shall assist to Managing Trustee/Secretary in relation to the Trust activities.

9, REMUNERATION OF TRUSTEES

The trustees will not be entitled to receive any remuneration as trustee but may reimburse to themselves all expenses actually incurred by them in connection with the trust of their duties relating thereto.

The funds and the income of the trust shall be solely utilized for the achievement of its objectives and no portion of it shall be utilized for payments of the trustees by way of profit interest dividends etc.

10, NUMBER OF TRUSTEES

The number of trustees shall be minimum three maximum ten including managing trustee and trustees of the Trust.

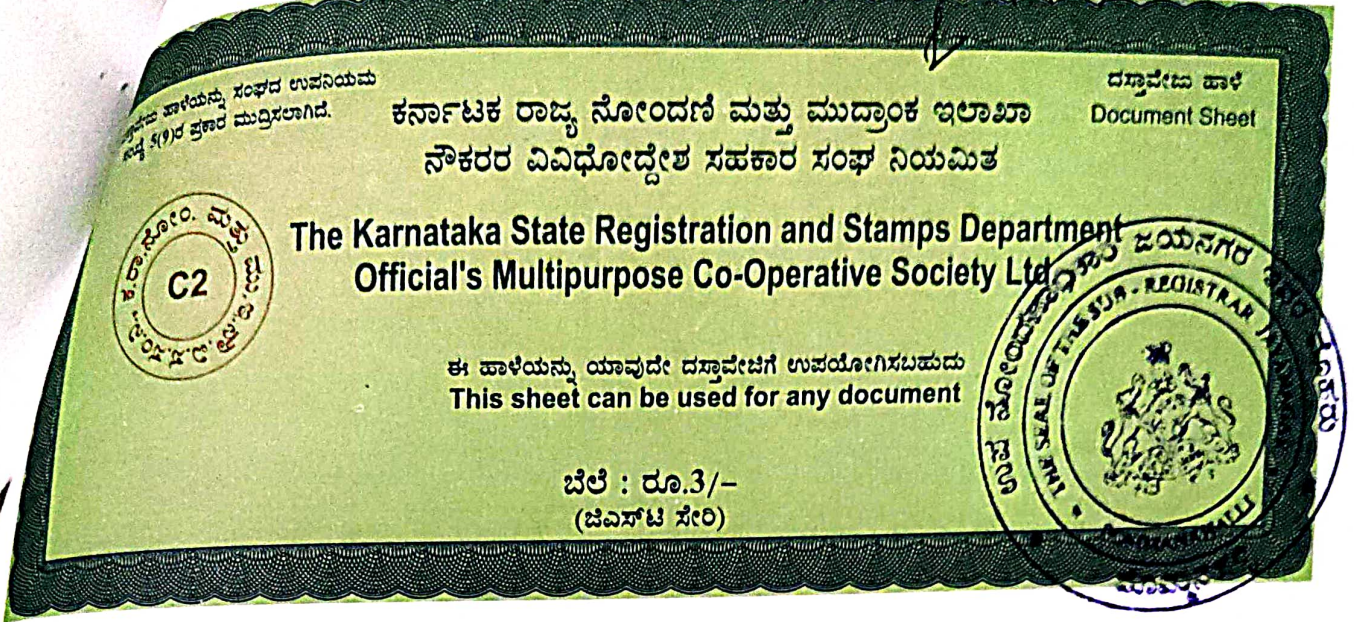
APPOINTMENT OF TRUSTEES

The Founder Trustees shall be at liberty to appoint additional trustees within the number mentioned above for such period or in such terms as to retirement and re-appointment as the trustees for the time being consider proper.

The trustees named above shall be the first trustees of this trust and they shall be trustees for their respective lifetime.

The founder trustees shall have liberty to remove the trustees/trust members when found and unfit incapable of acting as per the rules and regulation of the trust.

If any founder trustees of this trust die, retires or become unfit the legal heirs of the such trustees shall be appointed as trustees to the Trust.

The lifetime trustees shall make amendment of alteration of Trust Deed.

If any trustee dies, retires, become unfit or incapable of acting as a trustee, the Founder Trustees, if surviving at that time or otherwise the continuing or surviving trustee or trustees shall be competent to appoint a trustee in place of the trustee so dying, retiring or becoming unfit or incapable either for life or otherwise.

A Person shall cease to be a trustee either

A, If he/she without leave of absence does not attend three consecutive meeting\gs of the trustees or for one calendar year, whichever is longer, or

B, If he/she is requested to resign by all other trustees; or

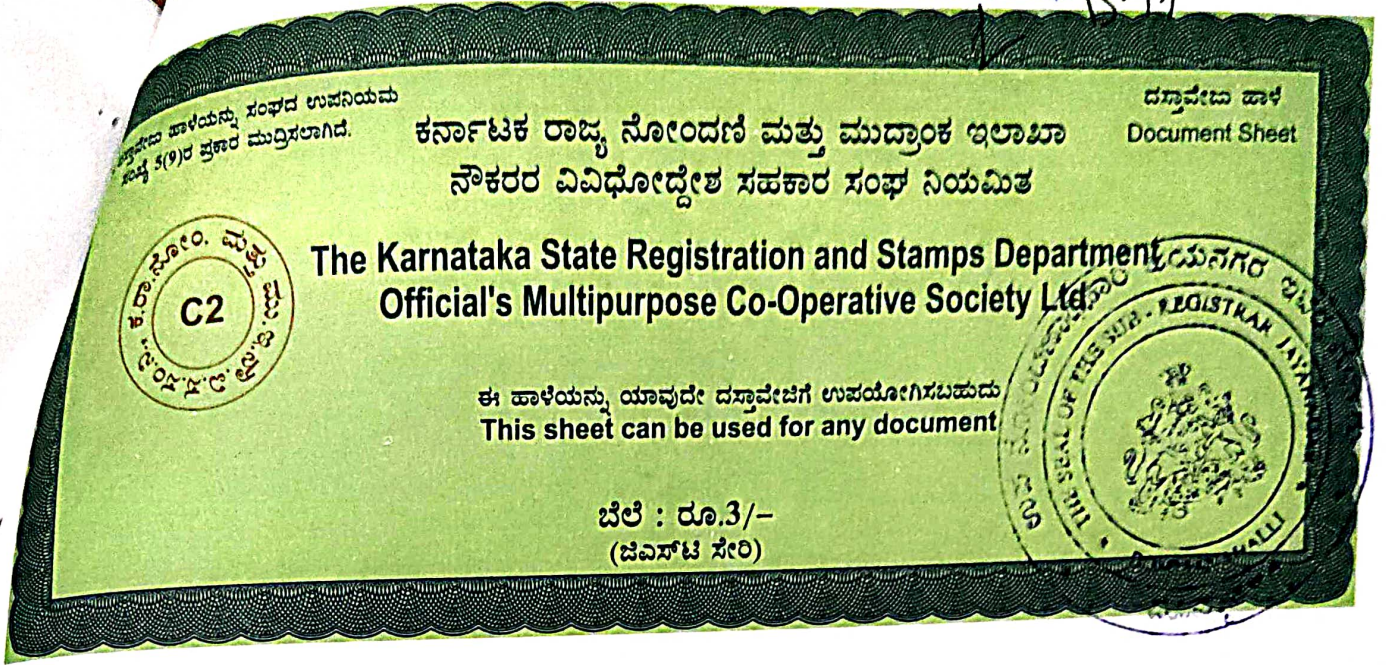
C, If he/she acts or does any things prejudicial to the objects of the trust, in the opinion of all other trustees.

13, QUORUM

The trustees may, from time to time, frame rules for the conduct and regulation of the meetings of the trustees.

14, INVESTMENT

The funds of the Trust shall be invested in the modes specified under the provision of Sec.13 (1) (d) r.w.s. 11(5) of the I.T. Act, 1961 as amended from time to time.

15, ACCOUNTS

There shall be maintenance of accounts of the Trust. A Chartered Accountant shall duly audit the accounts. Every year the accounts shall be closed on 31st March.

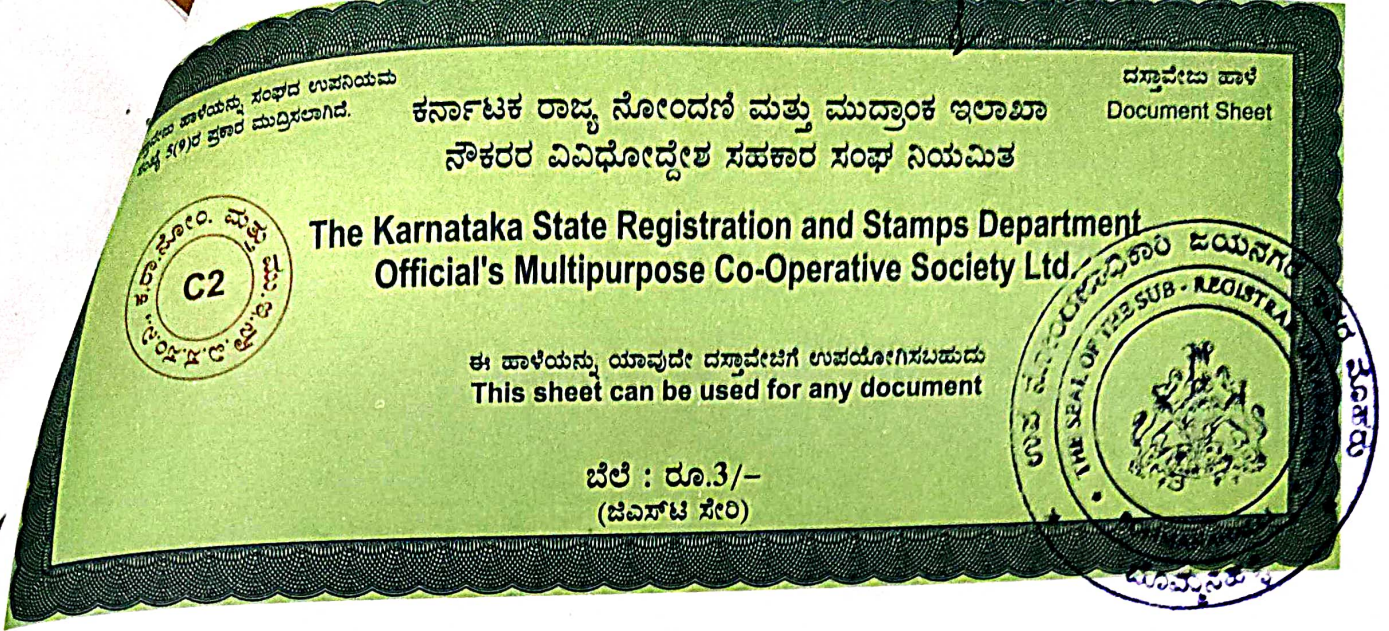

17, DISSOLUTION

In the event of dissolution or winding up of the trust the assets remaining as on the date of dissolution shall under no circumstances shall be distributed among the members of the Managing Committee/ Governing Body but the same shall transferred to another Charitable Trust/Trust whose objects are similar to those of this Trust and which enjoys recognition u/s 80G of the I. T. Act, 1961 as amended from time to time.

18, CLAUSE 5:

The Trust formed shall be irrevocable.

19, CLAUSE 6:

The benefit of the Trust shall be open to all irrespective of the caste creed or religion.

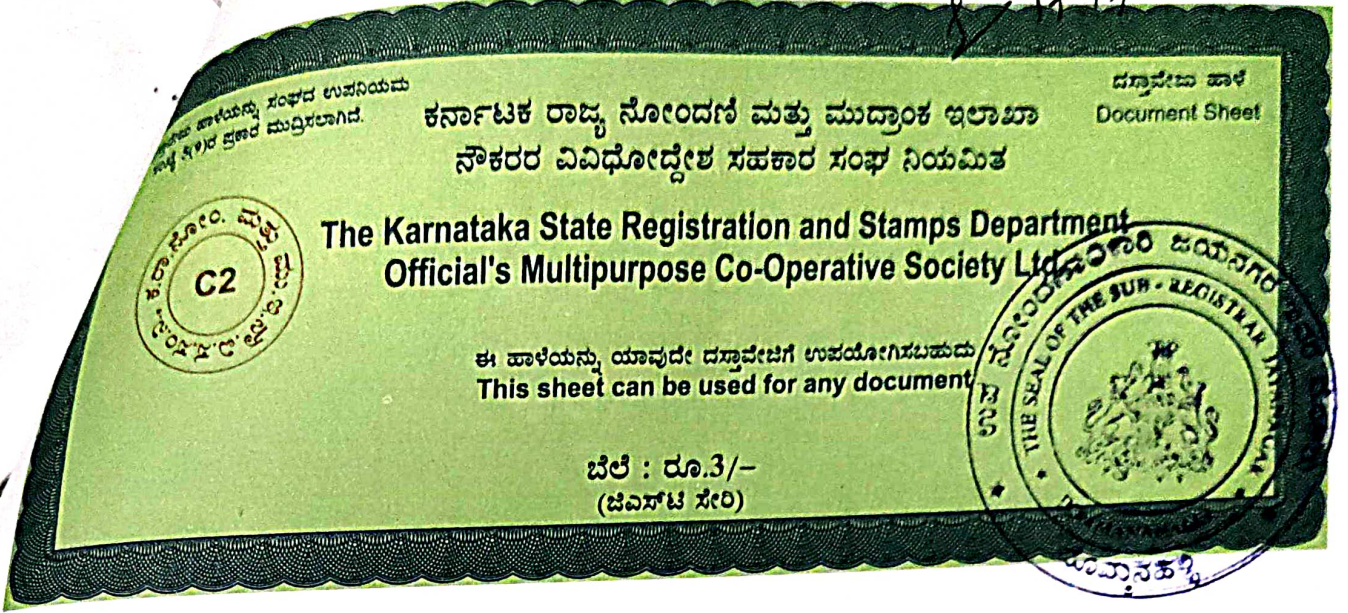
